## President's Message by K. Scott Abrams, CPA

We have all been introduced this winter to the term 'Polar Vortex.' Even the sound of it sounds cold, and those of us living in Wisconsin have felt the brunt of the Arctic cold and the protracted and sustaining winter months in 2014. Even given that scenario, we all await the first hint of spring and the change of season to a warmer and more palatable outdoor season!

But this is of but one minor change that is taking place in our state, with another one revolving around our continuing struggle in gaining passage of legislation that would help support Crime Stoppers and other crime prevention organizations throughout the State of Wisconsin. Assembly Bill 74, The Crime Prevention Restitution and Funding Bill was included in last year's State budget process, only to be vetoed by Governor Scott Walker, at the insistence of Attorney General J.B. Van Hollen. Quite simply, the proposed legislation would ensure that those actually committing crimes, and having the financial wherewithal to do so, would pay a surcharge on any felony and misdemeanor criminal convictions decided by the court. Funds from these surcharges would be disbursed through a county developed mechanism to crime prevention organizations, of which Crime Stoppers would be a qualifying organization. No State funds would be utilized in this process and no additional taxes are placed on the residents of Wisconsin through this legislation.

Assemblyman Andre Jacque, Brown County, is the sponsor of AB 74 and has been leading this charge in attempting to get this proposed legislation into law. Representatives from the Wisconsin State Crime Stoppers Board of Directors participated in the Judiciary Committee meeting earlier this year testifying in support of this legislation. The Wisconsin State Crime Stoppers leadership is requesting the assistance of all the local Crime Stoppers programs and any other interested citizens in the state of Wisconsin. This assistance can be accomplished in the form of a letter writing campaign to Governor Scott Walker and Attorney General J.B. Van Hollen. A letter of support written on your Crime Stoppers or personal letterhead identifying your support for AB 74, The Crime Prevention Restitution and Funding Bill, would lend additional support and credence in support of this Assembly Bill. The letter doesn't need to be a long and detailed correspondence, but rather an indication of your support, why you and/or your organization support the bill, and the ability to recoup funds from criminals to be placed into a local Crime Prevention Organization. Obviously, we feel strongly that with the implementation of AB 74, and we believe this crime prevention legislation will make our communi-

### Green Bay Area Crime Stopper receives \$7,000.00 donation

January of 2011 a young man in a wheelchair was hit and killed while traveling in a roadway in Green Bay. A witness stated the vehicle that hit the young man stopped a block away and then took off. The police had a description of the vehicle involved in the hit and run.

Information of the incident was placed on our website two days after the incident. The Green Bay Police Department made posters of the suspect vehicle they were looking for. The poster was sent to our President for review because it was going to have our Crime Stoppers logo and contact information on it. The poster was approved and was distributed throughout the community. The PD contacted the media to hype the posters which contained the description of the wanted vehicle.

The following day, we received a phone tip with some basic information about the accident. The following morning we received a web tip which contained additional information and we were able to have dialog back and forth with the tipster because of TipSoft programming and obtained more information. A contact was made with the officer in charge of the investigation and within 12 hours, the Green Bay Police Department had the vehicle and driver of the accident.

The court trail took place in November where the driver was found guilty. The driver stated he thought he had hit a garbage can.

On December 3, 2021 on what would have been the victim's 21<sup>st</sup> birthday the family presented to the Green Bay Area Crime Stoppers a check for \$7,000.00.

"Without (Crime Stoppers') help, we're convinced that this crime never would have been solved," Jeff Kennedy, the father of John "Mingo" Kennedy, said during a news conference to announce the donation from the John M. Kennedy Memorial Fund.

Kennedy's family presented the donation to Crime Stoppers President Hans Lux after showing a slide presentation with images from Kennedy's life.

Dear Governor Scott Walker and Attorney General J.B. Van Hollen:

I am writing today on behalf of the Wisconsin State Crime Stoppers, Inc. During our recent board meeting on October 2, 2013, the Wisconsin State Crime Stoppers reaffirmed its support by a unanimous vote of resolution regarding the initiatives included in the Crime Prevention Resolution and Funding Bill - 2013 Assembly Bill 74. In offering our support, it is important to know that Crime Stoppers programs are tax exempt 501(c)(3) organizations governed and operated by a local board of directors and work tangentially with law enforcement agencies in their respective communities and are considered crime prevention organizations under the current definition of Assembly Bill 74. Many programs in Wisconsin survive financially primarily through donations by citizens and businesses as well as conducting fundraising events in their local communities. Unfortunately, this is not enough for some areas in our state, which are large in terms of geography and not very well off financially, however, crime is still present in these areas. Despite the financial difficulties that many Crime Stoppers organizations face, our programs stand behind some very impressive statistics that underscores the success in resolving outstanding crimes, as the chart below indicates.

Rewards and administrative costs are borne by the local Crime Stoppers programs and usually with no additional cost to local or county law enforcement agencies. Crime Stoppers programs do not rely on any local, county or state taxes for their operations.

While reviewing the statutes from across the United States, 14 other states have some form or type of surcharge or restitution charge to the offending individual which is then ultimately dispersed to Crime Stoppers organizations or crime prevention organizations. Interestingly, the states of Mississippi, Florida and Texas have the most comprehensive statutes encompassing surcharges on almost all misdemeanors and traffic citations which are then placed into a Crime Stoppers trust fund and are disbursed through granting requests by either the county or Crime Stoppers organizations. Wisconsin State Crime Stoppers believes this 2013 Assembly Bill 74 amending the current statutes regarding restitution to Crime Prevention Organizations greatly enhances the continued existence for Crime Stoppers organizations in the state of Wisconsin.

In addition, the Wisconsin State Crime Stoppers recognizes the accountability and oversight required in administering this type of a program regarding the funds distributed through the grant award process. Wisconsin State Crime Stoppers will work with its 45 member programs in over 50 counties in the state of Wisconsin in communicating, networking and publicizing the appropriate measures and processes in order to remain compliant with the annual reporting procedures. If acceptable, Wisconsin State Crime Stoppers would like to offer its assistance in participating as an active or advisory member with any State oversight or accountability committees.

We understand the current economic struggles facing individuals and governmental units. Crime Stoppers has been an effective means in which to provide crime solving tools and techniques without additional costs to law enforcement agencies across the state of Wisconsin. We want to be able to continue providing this community service for the long-term throughout the state, but due to the economic turmoil, several Crime Stoppers programs have had to suspend or disband this community service due to lack of funding. We believe the 2013 Assembly Bill 74 provides a good start in establishing a proactive means in which to fund crime prevention organizations, such as Crime Stoppers rewards and administrative costs, by adding a surcharge to those individuals perpetrating crimes in the State of Wisconsin. Therefore, Wisconsin State Crime Stoppers supports the enactment of Assembly Bill 74 and encourages the approval and adoption as quickly as practical.

Again, on behalf of the Wisconsin State Crime Stoppers, thank you for allowing us to share our ideas and support for 2013 Assembly Bill 74.
